7/1/14 – Scott Auer, President, Smyrna Rotary Club

Scott attended North Carolina State University where he obtained a BA in Religion and Philosophy. He also played football there and was captain of the football team his senior year. After graduating from college, he became interested in home building and began a career in that field in 1990. For the past 19 years he has worked for several small custom builders in the Asheville area and a large builder/developer in the Atlanta area, where he worked for 12 years. In 2008, Scott started his own residential construction company, CrestHaven, LLC and is currently focused on residential remodeling, additions, basement finishes and outdoor living projects.

He was married in 2007 and recently they gave birth to a lovely daughter. Scott enjoys outdoor activities such as hiking and biking, sporting clays, bird hunting and amateur landscaping at their residence.

7/8/14 - William P. Marchione



Dr. William P. Marchione is a retired history professor who moved to Smyrna from Boston, Massachusetts in 2009. He is the author of the recently published (September 2013) "A Brief History of Smyrna, Georgia" and coordinates the popular "First Sunday of the Month" lecture series at the Smyrna Public Library.

A lifelong supporter of public libraries, Bill serves on the board of the Friends of the Smyrna Library and helped initiate a project to expand the library's local history collection with funding from the Friends of the Library. He also serves on the board of Smyrna's Golden K Kiwanis Club. He has lectured widely on aspects of local history over the past three years, and in 2012 was named "Volunteer of the Year" by the Smyrna Historical & Genealogical Society. He is currently at work on a slide/ lecture on the history of the Western & Atlantic Railroad which he plans to give in late 2014.

Bill's educational background includes a B. A. from Boston University, majoring in history and government; an M.A. from George Washington University, majoring in American

diplomatic history; post graduate studies in the history of the American South at the University of Tennessee; and a Ph.D. from Boston College, with concentrations in urban history, the history of American education, race and immigration history, and modern European history.

Bill taught at both the public school and university levels for over 40 years, and has received numerous awards and certificates of commendation for his work as an educator and public lecturer. His approach to the teaching of history was always highly innovative. In 1993 he was named the "outstanding American History Teacher in Massachusetts" by the national order of the Daughters of the American Revolution. In 1998 he received the coveted "Boston History Award," conferred annually by the Bostonian Society, for his work as a teacher, writer and Boston historian. In 2002 he received the "I Migliori Award" from the Pirandello Lyceum for his contributions to promoting Italian history and culture; and in 2008 he was named a fellow of the Massachusetts Historical Society. He has been active over the years in promoting oral history and has plans to inaugurate an oral history project in the local schools later on this year.

Bill has served in a number of elective and appointive positions. In 1983 he won election to Boston's School Board, representing the city's Allston-Brighton neighborhood, and headed the board's "Curriculum and Instruction Subcommittee" during his period on that body. His appointive positions have included service on Boston's U.S. Constitution and Bill of Rights Bicentennial Commission and on the Boston Landmarks Commission (the historical commission of the City of Boston), a post he held from 1995 to 2008, winning wide recognition as one of the city's strongest historic preservation advocates.

Bill has written seven books altogether as well as hundreds of articles for historical journals and the local press. In the period 1998 to 2002 he penned regular historical columns for several Boston area newspapers.

Bill also helped found several Boston area organizations, including the Friends of the Boston City Archives, serving as its Treasurer for several years. He was instrumental in the establishment of two state-of –the-art Boston-area museums--- the Brighton-Allston Heritage Museum and the Metropolitan Museum of the Waterworks. He has carried his interest and success as an exhibitor and curator to Smyrna, where he is working on a committee, established at the mayor's suggestion, to overhaul and expand Smyrna's outmoded and overcrowded History Museum.

7/15/14 - Paula Bevington

Paula Lawton Bevington owns Bevington Advisors, LLC, a philanthropic consultancy. Her primary client



is the Atlanta Legal Aid Society. She is a member of the State Bar of Georgia, a registered neutral with the Georgia Office of Dispute Resolution and a director of Lathem Time. A graduate of Saint Mary's College, Notre Dame magna cum laude and the Yale Law School, she was a Fulbright scholar in Venezuela. La Grange College awarded her an honorary Doctor of Humanities degree in 2012.

Paula spent most of her professional life at Servidyne, a company founded by her late husband. Initially a compressor remanufacturer, Servidyne evolved into an energy engineering company offering energy-conserving services to owners and managers of existing buildings. After the company was sold, she became a professional development officer, first at Scitrek and later at The Marcus Institute, now the Marcus Autism Center.

Active in the non-profit sector in areas ranging from health to legal services,

children's issues, the arts, business, education, international affairs and civil rights, Paula was the first woman president of the Rotary Club of Atlanta. Currently she chairs the boards of the Flannery O'Connor-Andalusia Foundation and the Justice Center of Atlanta and serves on several other boards, including the Task Force for Global Health and her high school, Lauralton Hall, in Connecticut. She is a former chair and Life Member of the Carter Center Board of Councilors.

7/22/14 – Georgia State Senator Hunter Hill



Born and raised in Cobb County, Hunter attended The Westminster Schools in Buckhead where he excelled at football. He played the sport at the United States Military Academy at West Point, where upon graduation he underwent Ranger training and led troops in Iraq and Afghanistan in three separate tours, achieving the rank of Captain, and later serving as a General's aide.

Upon his return Hunter entered the private sector, where he currently works as a Director of New Business Development for the security firm SecurAmerica. Previously he worked as a Real Estate Developer in Atlanta, with projects including Atlantic Station, as well as complexes at several local schools.

Hunter has a wife, Shannan, who is from the Atlanta area, as well as two young children, Hunter Jr. and Annie. He and his family attend The Church of the Apostles in Buckhead. Hunter was elected as the State Senator for the newly drawn District 6 in November of 2012. The 6th District includes parts of both Cobb and Fulton Counties,

Her leadership supports consulting and educational activities of a large team of SBDC professionals and facilitates innovation throughout Metro Atlanta and north Georgia on behalf of small business communities.

After spending several years focusing on her business, Alicia began looking for a way to serve her community and was introduced to Rotary by her sponsor, Herbert Hatton. She joined the Rotary Club of Carrollton Dawnbreakers in March 2005. Since her induction she has served the club as Service Projects Director, Fundraising Director and President in 2008-2009. She has been recognized by her club with the Dawnbreakers Rotarian of the Year, Dawnbreakers Leadership Award, John T. Lewis Mentor Award and the Dawnbreakers Excellence Award. June Deen, Senior Vice President of Public Policy and Health Promotions

American Lung Association in Georgia, North Carolina and South Carolina

June has been with the American Lung Association for many years with much of that time devoted to the Lung Association's policy issues. She worked to pass many of our state laws curbing tobacco use by kids, restricting public exposure to secondhand smoke and increasing taxes on cigarettes. She tracks air quality regulations and has expanded Mothers and Others for Clean Air throughout the Southeast. The American Lung Association has recently

launched LUNGFORCE, a new national to unite women in the fight against lung cancer and for lung health.

8/26/14 – Malaika Rivers, Cumberland Community Improvement District



Executive Director, Cumberland Community Improvement District

Malaika Rivers is responsible for leading the efforts of the Cumberland Community Improvement District (CID) in the Cumberland submarket in northwest Atlanta, Georgia. The Cumberland CID is the mechanism by which the area's commercial property owners advance roads, streetscapes, trails, beautification, and other infrastructure enhancements that improve their property values as well as the greater community.

With 21 years experience, Rivers works with commercial investors, developers, government partners and other stakeholders by raising seed funding through the CID's local commercial property assessments, leveraging them against public funds, and reinvesting them back into the community's infrastructure. Since its inception in 1988, the CID has successfully leveraged \$100 million local dollars into an

estimated half billion dollars in constructed projects. This has helped grow real estate assets in the CID to more than \$4 billion, with \$3 billion of that in commercial real estate value. A testament to the success of the CID, in 2013 the Atlanta Braves announced their intent to relocate to Cumberland and develop a billion dollar stadium and mixed-use development by 2017.

Rivers began with the Cumberland CID in 1996 when she was brought on to develop and manage the Transportation Management Association ("Commuter Club" TMA) which was also the first in Georgia. In 2006 she was named the first full time Executive Director of the CID to oversee the CID's growing portfolio of projects, including road, streetscape, trail, transit, commuter services, land use planning, beautification, parks, and more.

Under Rivers' leadership, the CID and its initiatives have been recognized and awarded nationally and internationally by the US EPA, US DOT, International Downtown Association, Georgia Planning Association, Association for Commuter Transportation, as well as notable coverage by the Wall Street Journal, National Public Radio, ABC World News and more.

Rivers has been named a "40 Under 40" by both Georgia Trend and the Atlanta Business Chronicle, a "25 Power Women to Watch" by Atlanta Woman magazine, and a "Woman of Achievement" by the YWCA. Rivers sits on the Board of Directors for the Council for Quality Growth, the Livable Communities Council, and is active with the Urban Land Institute. She is a committee member of the region's Environment and Land Use Committee and a graduate of the Regional Leadership Institute as well as Leadership Cobb. Rivers has also been an appointment of the Speaker of the House for a study committee related to the horse racing industry.

Prior to her current position, Rivers was with the Atlanta Regional Commission and before that, with private industry in Washington, DC and Northern Virginia. Rivers is a graduate of Virginia Tech and lives in the suburbs of Atlanta, Georgia.

9/2/14 - Gordon L. Jones, Atlanta History Center



Gordon L. Jones is the Senior Military Historian and Curator at the Atlanta History Center in Atlanta, Georgia, where he has worked for the past twenty-one years. Gordon is responsible for the care, exhibition, and research of approximately 12,000 objects of military origin, most of which relate to the American Civil War.

He was the writer and curator of the 9,200 square-foot signature exhibition *Turning Point: The American Civil War*, which opened in 1996, as well as a number of temporary exhibitions since that time, including *War in Our Backyards: Discovering Atlanta 1861-1865*.

Gordon holds a Ph.D. from the Graduate Institute of the Liberal Arts at Emory University, specializing in the Civil War in popular culture and the processes of remembering, commemorating, and recreating the past. Gordon also holds a B.A. in history from Furman University and an M.A. in applied history and museum studies from the University of South Carolina. He was born and raised in Greenville, South Carolina.

9/9/2014 - Judge Reuben M. Green

Judge Reuben Green presides over the Veterans Accountability and Treatment Court in Cobb Superior Court. Judge Green is a former enlisted United States Marine. While serving as a Marine, Judge Green received the Good Conduct and National Defense Medals, was meritoriously promoted twice, and was Honorably Discharged in 1993 after four years of active duty.

After serving in the Marines, Judge Green received his Bachelor of Arts Degree in Political Science from Lewis & Clark College in Portland, Oregon. He then graduated with Honors from Emory University School of Law.

Judge Green began his legal career at King & Spalding where his practice focused on employment discrimination, product liability, and general civil litigation. After September 11, 2001, he felt called to return to public service and became a prosecutor. Judge Green has served at all levels of prosecution including as an Assistant Solicitor, an Assistant District Attorney, and finally as a Special Assistant United States Attorney.

In 2010, Judge Green was appointed to the Cobb Superior Court bench by Governor Sonny Perdue and then was elected to a full term in 2012.

9/16/14 – Jim Kelly, Noted Author



James Floyd Kelly is a technology writer from Smyrna, GA. He received degrees in Industrial Engineering (Florida State University) and English (University of West Florida).

James began working in the IT industry in 1996 in Jacksonville, Florida. With his engineering and writing skills, he was hired to document the buildout of a multi-million-dollar data center. This duty required him to take almost six additional months of training related to networking, TCP/IP (the language of the Internet), data security, and other topics. After completing the job, James was hired by an

IT consulting firm in Houston, Texas as its lead systems/network administrator, responsible for maintaining all technology services for the 300+ employee firm.

In 1999, James was promoted to a Jr. IT consultant position; for two years, James traveled both locally and abroad to provide assistance to Fortune 500 corporations with assistance in benchmarking data centers for either purchase or sale. As a junior consultant, his primary duties were to document all technology related statistics and translate it for easier understanding by upper-level management teams. It was during this time that James began to develop his own methodology for structuring and writing large technology-related documents.

James left the IT consultant position in 2001 and partnered with two colleagues to start a small consulting business in Houston. The company provided technology training and network/security duties to small to medium-sized businesses. James provided some consulting duties but his primary job was documenting procedures, creating user manuals/instruction guides, and writing advertisement copy for white papers, brochures, and websites.

In 2004, James relocated to Atlanta, Georgia and opened his own company, Blue Rocket Writing Services, Incorporated, to provide customers with original technical content such as white papers, brochures, instructional manuals, and more. In 2006 his first technology book was published by Apress

and since then he has written over 25 books on a number of technology subjects that include building LEGO robots, programming, 3D printing, and 3D modeling CAD software.

During summers, James teaches electronics and robot building camps to students. He is a frequent writer for GeekDad.com and Makezine.com, and he and his wife, Ashley, live in Smyrna with their two young boys, ages 7 and 4.

10/7/14 - Bob Ott, Cobb Co. Commissioner

Bob Ott works for Delta Air Lines as an international and domestic pilot. He is also the president and owner of DBO Software. Ott has served in the U.S. Air Force and as a seventh and eighth grade science teacher.



His public service activities include serving on the Cobb County Planning Commission and Board of Zoning Appeals, Board of Trustees for Friends for East Cobb Park, as president for East Cobb Civic Association, Terrell Mill Homeowners Association, Transportation SPLOST Oversight Committee, Neighborhood Safety Commission, Vinings Corridor Study, Blueprint Cumberland and Powers Ferry Corridor Study.

Ott holds a bachelor's degree in biology from Bucknell University and a master's degree in systems management from the University of Southern California. He is married with two children and a member of Mt. Bethel United Methodist Church.


Commission District Two (Southeast Cobb) includes Cumberland, a major metro employment center bordered by three interstates. Convenient to Atlanta's Hartsfield-Jackson Airport, the area is home to major corporations such as

Home Depot, IBM and US Sprint and includes a nationally-ranked convention facility, the Cobb-Galleria Centre. The district is enjoying a resurgence in upscale residential development, which includes the Vinings and Smyrna communities.

10/14/2014 - Congressman David Scott

In 2002, David Scott was elected to the United States Congress. He is currently in his sixth term representing Georgia's Thirteenth Congressional District, which includes 6 counties around metro Atlanta: Cobb, Clayton, Douglas, Fayette, Fulton and Henry.

United States Congress



In Congress, David Scott is a strong voice for jobs, healthcare, education, our veterans, our children, and transportation. He serves on the Financial Services Committee, Agriculture Committee, and the NATO Parliamentary Assembly. He has passed several laws including student loan repayment assistance for law students who become public prosecutors and defenders so that top attorneys will be attracted to public service. He also recognized the importance of Fathers by adding Father's Day to the U.S. Flag Code as a day of special significance. He also bridged political gridlock to achieve National Heritage Area designation for the Arabia Mountain in metro Atlanta.

As a Member of the Financial Services Committee, Congressman Scott has stood with homeowners and neighborhoods during the financial crisis. He worked to enact the program to provide

struggling homeowners who are unemployed with up to 18 months mortgage assistance. He also helped create the mortgage assistance program Home Assistance Mortgage Program (HAMP), the Neighborhood Stabilization Program (NSP), and the Making Home Affordable Program. After major flooding hit metro Atlanta in 2009, he obtained financial support for his district and wrote the law to allow for flood insurance premiums to be paid in monthly installments rather than one lump sum. He ensured that Georgians receive two free credit reports each year, rather than the one annual report available to most of the country.

As a Member of the Agriculture Committee Congressman Scott recognizes that Georgia's largest industry is agriculture and he fights to protect the interests of Georgia's farmers, ranchers, and food processors. He also works to ensure that America's agriculture sector continues to grow and remains globally competitive. Scott currently serves as the Ranking Democratic Member on the General Commodities and Risk Management Agriculture Subcommittee, which oversees our nation's farm support system, commodity exchanges, and derivative swap financial regulations to prevent another national economic meltdown. Congressman Scott has sponsored legislation to keep food and nutrition prices down for consumers. He supports land grant universities (such as the University of Georgia and Fort Valley State University), recognizing the significance they play in fostering research and education, and improving the agricultural economy.

As a Member of the NATO Parliamentary Assembly Congressman Scott supports a strong American military and robust foreign policy and has demonstrated a firm commitment to America's relationships abroad particularly, with Israel and our NATO allies. Congressman Scott has provided strong leadership in passing a resolution at the 2012 NATO meeting, gaining the support of 27 other nations, to join the United States and Israel to stop Iran from securing a nuclear bomb.

Back Home in Georgia

Congressman David Scott spearheads a wide range of local initiatives that benefit his constituents. He sponsors annual jobs fairs that have secured over 7,000 jobs for his constituents. Congressman Scott also hosts an annual health fair, bringing free healthcare exams to help reduce breast cancer, prostate cancer, diabetes, AIDS, and other healthcare issues. He has hosted major home foreclosure prevention and mortgage assistance events, helping over 4,000 constituents find help keeping their homes. Congressman Scott has secured over \$367 million in federal funds for transportation projects in his district.

Congressman David Scott chairs the Georgia State Society and chaired the Georgia Inaugural Ball during President Barack Obama's Inauguration in 2013. He sits on the board of the Dean Rusk Center for International Law and Policy at UGA. He is a member of Alpha Phi Alpha (Beta Nu), a Mason and a Member of the 100 Black Men of Atlanta, Inc. He received a "Trumpet Award" in 2008, the Urban League's "Congressional Leadership Award" in 2010, and has been recognized by Georgia Trend Magazine as one of the "100 Most Influential Georgians" in multiple years.

Early Years

David Scott was born on June 27, 1945 on a farm in Aynor, South Carolina to Mamie Polite Scott and Albert James Scott. Soon after he was born, David's mother and father moved up north to take work as live-in domestics (maid/ cook and chauffeur/butler) for wealthy families, leaving David in the care of his maternal grandparents, Helen and James Burroughs, on the farm.

However, this family allowed David to live with his parents in Scarsdale, marking the first period in his life that he actually lived day-to-day with his parents. David attended Fox Meadow School and Scarsdale Junior High School.

At age 13, David moved with his parents to Daytona Beach, Florida where they bought a home and his father started a garbage collection business. David worked with his father on the garbage truck; and worked his way through school as a busboy, waiter and dishwasher at hotels and restaurants along Daytona's famous beach. David Scott graduated with honors from Campbell High School in Daytona Beach, Florida in 1963.

Higher Education

David Scott received several academic scholarships and attended Florida A&M University where he earned his BA degree and graduated with honors in 1967. During the summers of his junior and senior years at FAMU, David was selected to serve as a management intern in the office of the Assistant Secretary of Labor for Labor Management Relations in Washington, D.C. Upon graduation, he was awarded scholarships to the Wharton School of Finance at the University of Pennsylvania and he earned his MBA degree with honors in 1969.

Georgia State Political Career

David Scott began his political career in 1972 by working on Andrew Young's successful congressional campaign. In 1974, he was elected as a Georgia State Representative, where he served from 1975 to 1982. As State Representative, he authored laws to provide for gun safety, including creating background checks for gun purchases. He also made it a felony to knowingly sell or provide a firearm to a child or minor and held parents and guardians responsible for keeping their firearms away from children. Representative Scott helped create Peachcare, the health insurance program for children.

In 1982, David Scott was elected as a Georgia State Senator, where he served from 1983 to 2002. In the Senate, he successfully passed several major laws including a moment of silence for reflection or prayer in Georgia's public schools. He wrote the Georgia law that gives women with breast cancer surgery the

right to determine their length of stay in the hospital and level of medical care in consultation with their physician, rather than having insurance companies make such critical health decisions. He authored the law to limit and restrict landfills in residential neighborhoods, cleaning rivers and streams, and protecting underground water aquifers. He also passed the state law to provide sex education and AIDS prevention instruction in Georgia public schools.

Family

David Scott is married to Alfredia Aaron Scott. Their family includes two daughters, Dayna and Marcye; two grandchildren, Kimani and Kaylin; a son-in-law Kwame; and brother-in-law and good friend Hank Aaron. David Scott is the son of a minister and a man of strong faith who loves the Lord. He regularly gives guest sermons in area churches.


